12. COURSE OUTCOMES AND COMPETENCIES:

- Demonstrate a basic understanding of legal and regulatory processes and legal system as it relates to business organizations.
- Develop the fundamentals of legal research, learn methods of legal reasoning and analysis, and apply these skills in reading law cases.
- Become familiar with the terminology and concepts of Constitutional law, contracts, sales, torts, agency, wills, trusts, property, administrative law, the basic business organizations, intellectual property, and cyber-law.
- Know the different types of business organizations and their advantage and disadvantages and the process for establishing a business organization; go through the formalities of setting up a specific type of business.

13. ATTENDANCE REQUIREMENTS:

Students enrolled at one of the university's external campuses should make every effort to attend all class meetings. 16. COURSE REQUIREMENTS and GRADING CRITERIA:

Complete all assigned reading as indicated on the attached course schedule, participate in the on-line discussion board forums and complete all assignments, including case studies and exams when applicable. In case the student is unable to submit assignments on the due date, please make prior arrangements with the instructor.

Homework (30%) – There are six homework assignments, each worth 10 points. Homework assignments' detailed instructions are posted in Blackboard in their respective weekly folders.

Quizzes (20%) – There will be two quizzes. The quizzes will be consisted of multiple choice, as well as true and false questions.

Term Paper (40%) - The course term paper will require a minimum of 12 pages of content covering the Introduction, Body, and Conclusions sections. The paper title page, abstract, table of contents, and references page don't count towards the 12 pages requirement. Students are expected to utilize at least 10 scholarly (peer-reviewed) sources published within the last five (5) years. More detail information regarding the research paper will be provided in the classroom, including a review of American Psychological Association (APA, 7th ed.) writing styles, format, and rules.

Attendance (10%) - The student will earn 100 total points if attend, participate and complete all class meetings assignments for each class session. Each class session will be worth 12.5 attendance points. For the on-line sessions, the student will be required to complete all on-line assignments to earn the 12.5 attendance points.
